### Heavy Weight Throw for Distance

Thrown with one hand, 9' approach, without follow

### Light Weight Throw for Distance

Thrown with one hand, 9' approach, without follow

### Light Scottish Hammer Throw

Thrown with one or both hands, from the mark without approach or follow

### Heavy Scottish Hammer Throw

Thrown with one or both hands, from the mark without approach or follow

### Caber Turn

Qualification Caber and Champion Caber

### Heavy Weight Toss over the Bar

Thrown with one hand, from the stand without approach or turn of the body

*Overall Competition Awards for the Top 3 Amateur Athletes*

*Athletes must compete in all events of the overall competition to be eligible for awards*
